### **Organisational**

Organisational membership is open to all community based not for profit organisations who work with or on behalf of young people. Organisational members are entitled to two delegates each of whom has full voting rights at any general meeting of the Coalition and are eligible to nominate a person for election to any office or position in the Coalition. If an organisation operates more than one youth related program the organisation may apply to the Board for an additional membership which will carry the right to a further two delegates at any general meeting of the Coalition. Organisational members have access to member services and events at discount rates.
